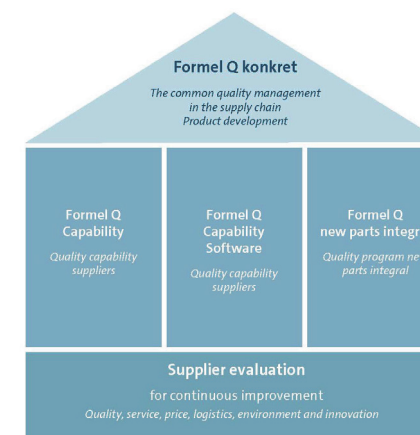
Objectives
