



Why MMOG/LE is important?

With the globalization and digitization development of automotive supply chain, the risk of constantly supplying is continuously increasing. With the resurgence of Global trade protectionism, it will be more challenging to ensure the constantly supplying of automobile supply chain in the future. Based on the risk of constantly supplying, more attention will be paid to the smooth operation of automobile supply chain.

Challenges for sustainability supply



Any step-in supply chain is interrupted, the whole supply chain cannot run e.g., IC of ECU case in 2020. In this background after American OEMs, the German OEMs and some of Chinese OEMs has start to request it (CSR).


Introduction of MMOG/LE

MMOG/LE V6 was official released in Q2 of 2023. Are you and your organization ready?

The Global Materials Management Operations Guideline / Logistics Evaluation (Global MMOG/LE) is an established industry standard that provides a unified assessment procedure for evaluating automotive logistics suppliers. The tool enables OEMs and suppliers to assess the logistical performance capabilities of the (sub)suppliers and the internal processes. It focuses on the following aspects:

- Unified evaluation of supply chain management, for both internal and external use
- Definition of supply chain management components in order to support continual improvement and enhance supplier performance
- Basis for benchmarking and identifying best-practice criteria
