VDA Analysis Tools

A new evaluation and documentation tool have been developed as a web application for the current tools of the VDA 6.3, VDA 6.8, VDA 6.7, FFA.

Chinese, English, German, French, Czech, Spanish, Turkish, Hungarian, Italian, Polish, Portuguese, Swedish, Korean and Japanese language versions have been integrated to support use at an international level.

INTRODUCTION

We currently offer three kinds of audit tools for VDA 6.3, VDA 6.7, FFA and VDA 6.8:

Tool A: VDA Analysis Tools Version 2.0 (including VDA 6.3 Reports, VDA 6.7 Reports, Field Failure).

Tool B: Analysis Tool 2.0 - VDA 6.8 Full-License. If you are only interested in VDA 6.8 report and not VDA 6.3, VDA 6.7 and Field Failure (FFA) reports in Tool A, you can buy this tool.

Tool C: Analysis Tool 2.0 - VDA 6.8 Add-ons-License. The prerequisite for purchasing this tool is that you already have Tool A and are interested in VDA 6.8 auditing.

Note: The product will be run at web browser in your computer tablet and only communicates with the server to validate the license, your audit data will not be uploaded any backend. Meanwhile you have the chance to test our product. You can request a test license via <https://test.vda-qmc-tools.de>. The test license will be activated the first time you are using it. It remains valid for 28 days.

① How to order VDA Analysis Tools?

STEP 1: Send email to VDA QMC China: booksales@vdachina.com.cn. Email title: VDA Analysis Tool purchase requirement

STEP 2: Confirm your order by replying the confirmation letter from VDA QMC China.

STEP 3: Provide the user(s) information and Fapiao details to VDA QMC China by mail.

NOTE: The user name cannot be changed afterwards.

STEP 4: Make the payment.

NOTE: So far, we can ONLY accept payment via bank transfer and Alipay.

② How to use it via web browser?

STEP 1: User(s) receive the product access link and license key from QMC WEB SHOP (qmcweb-shop@vda-qmc.de) after payment done.

STEP 2: Make sure the internet linked and past the access link the the web browser.

STEP 3: Start the audit. (Internet are not necessary during audit).

NOTE:

1. We recommended using internet browser like Edge, Chrome and we are not suggested using 360 and Safari browser because the performance is not good.
2. Due to the audit data will not be uploaded to any third party server, you will not be able to see the previous audit records when you change your computer, you can do this by exporting the report first and then importing it to a new computer.
3. Due to the audit data will not be uploaded to any third party server, the audit data will only be kept in the history of the local browser, so please turn off the "Clear history when closing browser" option to clear the history when using this tool, otherwise the audit records will be deleted and cannot be found back. We recommended that you export and save the audit report to your computer after each audit.
4. This tool can be installed on your computer desktop, but only via Edge or Google Chrome. Please contact booksales@vdachina.com.cn for more detail information.
